On behalf of FEANTSA, I would like to thank you for joining us in Berlin and welcome you to our 2018 Annual Policy Conference.

Our annual conference serves as a useful opportunity to not only reflect on our past year but also to look to the future and the direction that the homeless sector is moving in. Earlier this year, FEANTSA published the Third Annual Overview of Housing Exclusion in Europe, which paints a startling picture of rising homelessness across almost every EU country. At the same time, the United Nation's Sustainable Development Goals have committed our governments to ending poverty, and by extension homelessness, by 2030. The EU Urban Agenda's Urban Poverty Partnership has also called for an EU target of ending homelessness by 2030 and FEANTSA's "Be Fair Europe – Stand Up for Homeless People" campaign is working to ensure homelessness remains high on Europe's post 2020 agenda.

Many in our network are providing essential and often emergency services to an ever-growing population experiencing homelessness in a context where their services and the people they work with face cuts to funding. While we are under pressure to respond to this rising crisis, it is important to consider and reflect on the bigger picture and how we respond to homelessness. What are the future challenges for the homeless sector, and are we equipped to respond to them?

The demographics of homelessness are changing. While the number of people experiencing homelessness rises, so does the number of different profiles of people affected, from women, migrants, young people and the LGBTIQ community to people with disabilities. Do we have the correct services in place to support their specific needs? Can we broaden the application of Housing First to support the needs of vulnerable homeless

youth or women with experiences of violence? Are we managing the current homeless crisis or are working towards the eradication of homelessness?

With the rising cost of housing across Europe we need to be equipped with the correct resources and solutions to prevent households from becoming homeless and to have affordable housing stocks to move people out of shelters. Do we have the capacity to develop and deliver innovative and affordable housing solutions complemented by relevant supports to prevent homelessness?

The proclamation of the European Pillar of Social Rights last November recognised the right to shelter and housing. How can we practically vindicate the right to housing and take human rights-based approaches to tackling homelessness?

These are just some of the important questions we should ask ourselves. The team at FEANTSA have worked hard to develop a conference programme that addresses these important questions. Our keynote address by Professor Eoin O'Sullivan will provoke debate and discussion about how we move to 2030 while our diverse set of workshops will provide the framework to answer key questions we need to address if we are committed to reducing and ultimately ending homelessness.

All FEANTSA members are invited to participate in FEANTSA's General Assembly to review the activities of the past year and to discuss key actions for the coming years.

**14.00-17.00 – Pre-Conference Programme**

The Pre-Conference Programme is made up of Site Visits and Working Spaces which conference delegates can participate in the day before the conference.

**Site Visits:**

The local site visits to services in Berlin offer conference delegates the opportunity to visit services for people who are homeless and include the following:

*1. Betrieb Berlin Südwest Krisenhaus Schöneberg (Kolonnenstraße 10 10829 Berlin Germany, meet at entrance)* This service provides emergency housing for men and women who are threatened with the loss of their housing, who can no longer live in their home or are homeless and in an acute crisis. The service further provides social and educational supports and offers accommodation in single or double rooms. Around the clock supports are available to the residents.

*2. EAF – Erstaufnahmeheim Forckenbeck (Forckenbeckstr. 16/17 14199, meet at entrance)* The primary goal of this facility is the elimination of chronic homelessness. For this purpose, it provides single and shared rooms for single people and families. In addition, there is also a socio-pedagogical



advice service which provides supports based on an individual needs assessment and their profile.

*3. CumFide - Wohnverbund (Seydlitzstrasse 22 10557 , meet at entrance)*  
Eingliederungshilfe The facility "CumFide" provides therapeutically assisted living for people with mental illness. The target group of the service are people experiencing homelessness with alcohol addiction and resulting mental illness. The service provides integrated care and services to support residents in living an independent and self-determined life.

*4. Zentrale Beratungsstelle (Levetzowstraße 12a 10555, meet at entrance)*  
Für Menschen in Wohnungsnot The Central Counselling Centre for People with Housing Shortage (Zentrale Beratungsstelle für Menschen in Wohnungsnot Berlin) offers advice and further assistance for people with no housing and people who are at risk of losing their housing. The Counselling Centre offers advice and support in navigating the help system in Berlin. The service offers advice five days a week and advocates with clients and accompanies people on appointments. The Centre also provides clients with over 1800 postal addresses which allows them to overcome administrative obstacles when dealing with official state agencies.

*5. Eva's Obdach At "Eva's Obdach" (Eva's Shelter) and "Eva's Haltestelle" (Eva's Stop) (Hinter der Katholischen Kirche 3 10117, meet at entrance)* Interested people can learn about two cooperating institutions of the Social Service of Catholic Women. Evas Obdach is a women-only emergency accommodation that offers social advice services. It is located at the Catholic Church of St. Hedwig. The service provides a safe place to rest, a place to talk and professional support for women who are homeless or in danger of losing their home. Postal addresses can also be set up here. The offer is free, unbureaucratic and anonymous!

*6. Haus Grabbeallee (Grabbeallee 63 13156, meet at entrance)* The transition house "Haus Grabbeallee" offers social and education supports for up to 24 homeless men in single rooms. During their stay, service users develop and work towards their individual goals to improve their living situation. Residents are supported with advice and assistance in addressing the underlying causes of their homelessness. These could be addictions, debts or mental health problems. Independent living is supported supplemented by additional efforts to promote social interaction.

*7. mob e. V. (in Zukunft vermutl. : Straßenfeger e. V.)*

*8. Gangway e.V. Gangway (Schumannstr.5 10117, meet at entrance)* This is a street work project for young adolescents and adults at different hot spots across Berlin. Around 75 social workers work in 23 teams, who meet clients who are rough sleeping in places such as public squares and streets. Our goal is to empower people to become independent. The range of services and supports offered by Gangway e.V. include advocacy support and service navigation with local authorities, employment supports and mediating conflicts between young people and their parents or other relatives to prevent homelessness. Gangway e.V. was founded in 1990. It is supported by the Senate of Berlin, by local administrations and supported by private donations

*9. Seeling Treff ( Seelingstraße 9 14059, meet at entrance)* Seeling Treff is a day centre in Berlin-Charlottenburg for both people experiencing homelessness and people living in poverty. The service is open six days a

week from Monday to Saturday. Seeling Treff offers counselling, advice and supports to support people exit homelessness in addition to basic and emergency services including, i) breakfast and lunch, ii) clothing, iii) washing facilities, iv) showers and hygiene services, iv) locker and storage space and v) postal address. Additionally on Fridays the Frostschutzengel service offers counselling for European citizens in their respective languages. While on Mondays healthcare is provided by doctors and nurses from Caritas Ärztemobil, a bus customized and equipped for mobile medical treatment.

*10. Ambulanz der Berliner Stadtmission (Lehrter Straße 68 10557, meet at entrance)* Homelessness and poor physical health are closely linked. The Berlin City Mission offers a lowthreshold, free and anonymous access to medical care for people experiencing homelessness. Realising that the needs of homeless people differ this flexible service includes i) daily medical care in the Lehrter Straße emergency shelter, ii) regular, free anonymous consultations for all people without access to standard medical care iii) street ambulance and mobile medical care service including a driver, a doctor and a translator and iv) a year round care room for homeless people who cannot live on the street due to acute health problems and who cannot be cared for in regular hospital services.

*11. Wohnungslosentreffpunkt Unter Druck e.V. (Oudenarder Str. 26 , 13347, meet at entrance)* Unter Druck -Kultur von der Straße e.V. was founded in 1992 and began as a theatre project by Jan Markowsky who was at the time homeless. It is a Berlin-based association for the homeless, the socially excluded and marginalised. Unter Druck has a non-hierarchical structure and the 4 running of daily activities are decided at weekly meetings attended by a mixture of clients, volunteers and staff. The services create a space for people who are homeless during the day, protected from discrimination and harsh weather and to provide them with a routine and

structure and activities, while the night shelters are closed.

The association has two locations in Berlin. The Unter Druck café, a meeting place for homeless and social marginalised people at Oudenarder Str. 26 in the Wedding area, and the Czentrifuga atelier complex at Markgrafendamm 24 in Friedrichshain.

*12. ALBATROS - Projekt "Wohnen Pankow - psychosoziale Unterstützung" ( Matenzeile 26 a, 13053, meet at entrance)* In Berlin, social structures are juristically differentiated between people who are homeless and have social problems and people who are mentally handicapped. Often, however, people fall between these legal gaps. The project Wohnen Pankow of ALBATROS combines the approaches from both sites and wants to help people who are usually not reached by the help system structure with innovative approaches.

## **Background on Working Spaces**

### *What are they?*

Working Spaces are hosted by organisations wishing to tap into the expertise of the FEANTSA network.

### *Working Spaces v Workshops*

Workshops allow for broad discussions on policies & practices around thematic issues within the homeless sector, and allow delegates to learn about recent trends and innovations. Working Spaces, however, aim to have a specific and practical follow-up after the conference, led by the session host. This could be an EU project or an effort to shape the policy direction of an organisation.

### *Why participate?*

You will have the opportunity to meet and network with delegates that share similar interests to you, as well as engaging in debates on specific policy outcomes. You can help shape the work or outlook of the organisation hosting the session and learn about other European approaches to homelessness.

## List of Working Spaces

### *1. Protecting the Rights of Destitute Mobile EU Citizens - Hosted by PRODEC (Galerie B)*

PRODEC is a project that focuses on rights of destitute mobile EU citizens in three Member States: Belgium, Germany, United Kingdom. The project leader is FEANTSA and the partners are Eurodiaconia 5 at EU level, AMA in Belgium, GEBEWO in Germany and St. Mungo's in the United Kingdom. The project assesses how national legislation has an impact on access to social benefits and on the right to reside for destitute mobile EU citizens and whether it is in line with the EU acquis. The Working Space will provide the opportunity to learn more about the outcomes achieved in the first twelve months, particularly with regard to the complaint filed against the UK, the national legal fitness checks and the materials that homeless services have been developing in order to raise awareness about rights of destitute mobile EU citizens.

### *2. Westminster HELP (Galerie C)*

The Westminster Housing and Employment Learning Project (HELP) has developed a one-stop-shop service which integrates services related to housing, employment and health support to deliver holistic and person-centered approaches to vulnerable households through the use of a personal case handler, or case manager. This Working Space will present some of the findings of the project's first year in operation and key learning about the successes and challenges of bringing integrated services together.

### *3. FEANTSA Youth (Conference Room 1)*

FEANTSA Youth is a network of professionals committed to ending youth homelessness in Europe. This Working Space is geared towards conference delegates with an interest in youth homelessness. The session will include i) a snapshot on youth homeless developments from participants, ii) a review of a European definition for youth homelessness and iii) a discussion on the preliminary findings of a EUROFOUND survey on disadvantaged youth's



access to homeless and housing services.

#### *4. EU Urban Poverty Partnership – Urban Agenda*

#### *5. Housing First Europe Hub (Conference Room 2)*

This Working Space is open to all participants who are interested in learning about the Housing First Europe Hub's activities. This meeting will be particularly useful for organisations active in national Housing First networks, and those who are considering adopting Housing First in their communities. Topics to be discussed include methods to share information and practice; strategies to overcome obstacles in implementing Housing First, and planning for useful European tools to promote and deliver Housing First. #### *6. Street Cycles Scotland (Conference Room 4)*

Simon Community Scotland's Street Cycles is a brand new outreach service, which was launched to practically respond to an increase in rough sleeping to the south and west of the city of Glasgow, areas which on foot would be too far out of the city centre to access effectively by our existing team. This service is the first street outreach by bicycle in the UK and our tourer-style bikes carry all of the essential support items required to meet the needs of people who are sleeping rough on the streets. The other remarkable part of this service is that it is staffed by volunteers who have been carefully trained to provide this type of support. The service is already having a fantastic impact in Glasgow and we look forward to its further development and promotion in the coming months. The service was funded by Glasgow's Rangers Charity Foundation.

### Getting to the Conference Venue from Berlin Main Station:

Take S 5 (to Westkreuz), S 7 (to Potsdam) to Berlin-Charlottenburg. Take the U7 to S+U Rathaus Spandau. Leave the underground at U Rohrdamm, cross the Nonnendammallee into Rohrdamm, where the hotel is situated just about 400 meters on the left.
