The FEANTSA General Assembly is open to all FEANTSA members to participate. During the meeting members will receive updates on FEANTSA's work programme, priorities for the coming months and years and the opportunity to shape our networks work around ending homelessness in Europe.

### Site Visits 15.00

Site visits are open to all conference participants, as part of your registration you can select which site visit you want to attend. Please note site visits are capped with a limited number of availability, places are secured on a first come first served basis.

A series of site visits have been organised by our Irish members. An overview of the visits are below.

#### ***Sophia - Sean McDermott Street – 62 – 63 Sean McDermott Street Lower, Dublin 1, Ireland***

Long term supported housing for couples who have experienced homelessness and have complex support needs. Service has been in operation for 5 years and offers 24 hour on site supports to couples who live in their own door apartments. Over 90% of residents have both addiction and mental health support needs.

#### ***Sophia Cork Street – 25 Cork Street, Dublin 8, Ireland***

Long term supported housing for families, couples and individuals who have experienced homelessness. All own door independent apartments. Housing was built on lands formerly owned by a religious order and has refurbished buildings repurposed as apartments on site. On site services include childcare, and a cafe along with onsite qualified support team.

#### ***Dublin Region Housing First – Peter McVerry Trust – St. Catherine's Foyer, Marrowbone Lane, Dublin, Ireland***

Visit and discussion with the Dublin Region Housing First team which is operated by Peter McVerry Trust on behalf of Dublin's four local government areas and the regional homeless executive.

#### ***Urban Regeneration & Vacancy – Peter McVerry Trust – 181 – 187 Townsend Street, Dublin 2, Ireland***

Visit to three urban regeneration projects in Dublin City Centre. The projects include two social housing schemes under construction/regeneration and one completed scheme. The projects are examples of how long term vacant and derelict buildings can be transformed into housing pathways for people impacted by homelessness.

#### ***Bellevue House Children's Home in Tallaght – Novas – Haarlem Court, Old Court Road, Killinenny, Dublin 24, Ireland***

Situated in South County Dublin, Bellevue House is a six-bed residential service for unaccompanied minors from outside the EU, seeking asylum. It is a long-term specialised children's service, catering for minors between the ages of twelve and eighteen. Opened in 2002, Bellevue provides a holistic care programme for the young people



residing there. Meeting fundamental needs such as shelter, heat and food, our work is married with an understanding of and respect for the cultural, religious and ethnic needs of residents

***Women's Service – Novas – Rathgar Family Hub, 66 Orwell Road, Dublin, Ireland***

Small Supported Temporary Accommodation service dedicated to women experiencing homelessness. 14 women live in this service, in single ensuite rooms.

***Tus Nua – DePaul – Abigail Women's Centre, Tus Nua, Kildonan Road, Dublin 11, Ireland***

Tus Nua Apartments is the first service of its kind in Ireland supporting women leaving prison. Tus Nua is co-funded by the Irish Government and the European Social Fund as part of the ESF Programme for Employability, Inclusion and Learning 2014-2020. Tus Nua was established by Depaul as a result of research and visits to prisons in Dublin by the Guild of St. Philip Neri, and a St. Vincent de Paul conference, who recognised an acute need for programmes to assist women released from prison in their transition to independent living in the community.

***Sundail House – Depaul – Sundial House, 140 James Street, Dublin 8, Ireland***

The first of its kind in Ireland, Sundial House is a purpose-built, long-term housing project which provides low threshold housing for people who have experienced extended periods of street homelessness and have entrenched alcohol use issues. The service is managed by Depaul in partnership with Túath Housing.

***Longfields Supported Temporary Accommodation – Dublin Simon Communities – 9/10 Lower Fitzwilliam Street, Dublin, D02 TN35***

30 bed Supported Temporary Accommodation(STA) Unit, provided in partnership with the Dublin Region Homeless Executive(DRHE). The building provides a positive and inspiring space to support clients in changing their lives.

Dublin Simon emergency services are provided on a low threshold basis with a harm reduction model and a full suite of services for clients. The aim of our emergency services is to support our residents to move on to and to be able to sustain long term accommodation. We have several measures in place to ensure a quality, wraparound support service is provided to enable people to move out of homelessness.

- Care and case management are provided.
- Programme of meaningful activities and life skills development are delivered
- Health and safety assessments, reviews, policies, audits, a maintenance team and full time cleaners.
- Breakfast, lunch and dinner are provided for all residents.

***Working Spaces 15.00 – 17.30***

Working spaces are an opportunity for FEANTSA members to come together in a non-formal space to discuss various topics related to our work.

***Roundtable on Youth Homelessness – Long Room, Croke Park Hotel***

This session is led by A Way Home Canada and will bring different stakeholders from across Europe together to discuss next steps around combatting youth homelessness in Europe. Since the last roundtable held in 2019 in Porto the number of coalitions combatting youth homelessness has grown. This session will be an opportunity to take stock on recent developments, and discuss priorities and goals in the coming months and years including Housing First for Youth and Young People.

***Open Space to Discuss the Humanitarian Crisis Resulting from Ukraine – Fitzroy Room, Croke Park Hotel***



The war in Ukraine has placed growing pressure and demands on homeless services to support people fleeing the war. The homelessness sector is involved in every stage of managing the arrivals of refugees, from reception, offering shelter and basic needs support to counselling on administrative issues. The crisis following Russia's invasion also led to a huge wave of solidarity across Europe and new policies and legislation were activated at EU level.

In this open space we aim to discuss and share experiences on what solutions were implemented at national level, and what were the challenges that civil society confronted with since the invasion of Ukraine. We will also look at policies set in place and funding opportunities for services receiving refugees fleeing Ukraine, while critically assessing the responses from EU and its member states..

### ***Energy Poverty & Homelessness – Murphy Room No. 2***

The link between energy poverty and homelessness isn't always obvious, but with the cost of living rising rapidly across Europe, with particular pressure on the cost of energy, it is a growing topic. This working space will be an opportunity for participants to share their experiences around high energy prices and the impact it has on working with people experiencing homelessness and in managing shelters and services. Questions will also be raised around renovations and their impact. This will be a space to explore solutions and highlight the type of policies we should advocate for.

### ***Housing First Europe Hub – Networking Space – The Annie Moore Room, CHQ Building, Custom House Quay, North Dock, Dublin 1.***

The Housing First Europe Hub is a partnership established by Y-Foundation and FEANTSA and brings together over 30 housing providers, NGOs, cities, governments, and experts on Housing First. This networking session is an opportunity for partners and all who are interested in learning more about the Housing First Europe Hub's activities and resources. ## Get to know our innovative formats:

**Workshops** – lasting 2hrs, these sessions are dynamic with a strong focus on participant engagement. Workshops will usually have two speakers, who will share their expertise or experiences on a given topic. But the overall session will be designed to allow participants to share their knowledge, challenges and solutions, with time and space for breakout groups to allow for better exchanges.

**Seminar** – lasting 1.5hrs, these sessions are more traditional, with a stronger focus on the expertise of the speakers. The speakers will present for longer, with the focus on Q&A with the speakers, rather than exchanging practices among the participants.

**In Conversation with...** – lasting 1hr. FEANTSA has a rich network and expertise. These sessions are a space to meet with an expert in our field. There is no specific presentation, just a conversation with the expert where participants can ask them questions and get their insights.

**Spotlight on....** – lasting 45 mins. There are so many topics that FEANTSA can't fit everything into a workshop, particularly for emerging or developing topics. These sessions will include a presentation for an expert on a specific topic for about 20 minutes, to share their knowledge, which is followed by time for questions and answers among participants

### **Young Women Experiencing Homelessness (Hogan Suite, Level 5, Croke Park)**

How can homeless services better meet the needs of young women experiencing homelessness? This workshop will present the key principles developed by FEANTSA Youth during our 2021 study session, along with insights into the work of peer workers to support young women experiencing homelessness. Participants will have the opportunity to familiarise themselves with ways for supporting young women and will also have the opportunity to break out into smaller groups to discuss how they can adapt their services to better meet the needs of young women experiencing homelessness.

### **Healthcare for People Experiencing Homelessness (All Start Suit 682, Level 6, Croke Park)**

This workshop will identify methods for improving access to healthcare for people experiencing homelessness. Discussion topics will focus on health inclusion and how to make secondary care more inclusive, with a presentation of successful practices from the 'Inclusion Health pilot project' at St James's Hospital in Dublin. The perspective of homelessness services from the ground will also be included, with the purpose to increase connection between the two sectors.

Two presentations will be delivered after which participants will have the opportunity to discuss their work context and share their experiences in smaller breakout groups.

Access to accurate and reliable data is a key component of strategies around preventing and combatting homelessness. Measuring progress towards goals around ending homelessness is critical to evaluate the efficacy of strategies and policies around homelessness. This seminar will provide insights into methods of measuring homelessness with expert insight from Denmark with Lars Benjaminsen and from Ireland with Eoin O'Sullivan

### **Working with cities: what are the housing solutions to specific urban challenges? (Suite 688/689, Level 6, Croke Park)**

In this workshop participants will hear from cities and public authorities, as they highlight some of the key challenges, they face related to combatting homelessness, along with some ideas for how a city can proactively respond to those challenges. Following the presentations, participants will be broken into smaller groups, where they will have the opportunity to discuss the challenges, they encounter in their context at city level for combatting homelessness, and share solutions with one another.

### **Seminar: Challenging measures that criminalise homelessness (Suite 686, Level 6, Croke Park)**

There is overwhelming evidence that people who are homeless are being criminalised for the activities they are forced to carry out in public space. This approach is highly problematic for organisations working with homeless people and many are advocating for changes in different ways.

The workshop will showcase different initiatives to challenge these measures in Europe including a campaign by organizations in the United Kingdom to scrap the Vagrancy Act and approaches from Sweden to combat and legally challenge the current trend of anti-begging measures.

### **Spotlight on Danish Homelessness Strategy (Canal Café, Level 5, Croke Park)**

The new Danish Homelessness Strategy is flipping the homeless sector on its head, through prioritising housing and housing first solutions over the use of shelters and hostels. The strategy aims to bring 4,050 Housing First units for people experiencing homelessness. In addition to financing more housing the strategy will limit the funding for hostel use. Municipalities will only reimburse the first 90 days of a person stay in a hostel, this will be phased in between 2023-2025 as part of an effort to transition from a reliance on shelters to housing, however funding will remain for staying in Housing First units. Additionally the municipalities will be required to develop action plans with individuals experiencing homelessness to ensure that when they are discharged from a hostel a home with right supports is available.

### **Spotlight on Annual Overview of Homelessness & Housing Exclusion (All Star Suite 681, Level 6, Croke Park)**

This session will start with a presentation of the main highlights of the 7th Overview of Housing Exclusion in Europe 2022 by FEANTSA and Fondation Abbé Pierre, going through homelessness and housing exclusion recent data, learnings from policy measures taken in the wake of the pandemic and how the end of moratoriums on



evictions impacted homelessness and housing exclusion. The presentation will be followed by a Q&A session with participants.

**Seminar: Who is the homeless sector? (Hogan Suite, Level 5, Croke Park)**

Who is the homeless sector in Europe? This basic, but quite fundamental question, has been the focus of research completed by the European Observatory on Homelessness. Over the past four years the Observatory has been conducting comparative research on the homeless sector across Europe examining the quality of



services, regulation of the sector, employment conditions, human resources management and financing and cost-efficiency of homeless services. This seminar will present some of the key findings of the research.

### **Workshop: Housing for Migrants & Asylum Seekers during crisis periods (All Star Suite 683/684, Level 6, Croke Park)**

This workshop will discuss the access to housing for migrants and asylum seekers, including schemes designed and delivered by governments during the COVID19 lockdown periods as well as support solutions identified by civil society organisations. In the current context where Europe is confronting with a two-years health crisis and a recent war in Ukraine which has led to over 400 000 displaced individuals in its first three days, identifying solutions and policies that work to ensure adequate accommodation for all is not only timely, but extremely important.

This workshop is for organisations who support migrants and asylum seekers in their services and who are familiar with policies in the field of homelessness and migration. Following the presentations, participants will have the opportunity to ask questions before being broken into smaller groups.

### **Seminar: Building Blocks for a Campaign on the Right to Housing (Suite 688/689, Level 6, Croke Park)**

Ireland, and many other EU countries, is on a campaign to advance the right to housing in both legislation and its constitution. The language of rights, and legal frameworks, can often be presented in an inaccessible language. This seminar will look recent constitutional campaigns around marriage equality and a woman's right to choose and ask to explore the lessons that could be learnt from organisations interested in campaigning around the right to housing.

**Spotlight on Sex Work & Homelessness with Grace Sumner (All Star Suite 681, Level 6, Croke Park)**

In this session Grace Sumner, a sex worker who was previously homeless, will discuss the intersection of homelessness and sex work. This session is not about the labels organisation use, such as sex work, survival sex, sexual exploitation, sex for rent etc and it is not about focused on moral judgements about the behaviour of people experiencing homelessness. Rather its an opportunity to shine a light on a topic often considered too controversial or taboo. Grace will present an overview and a critique of the different models around sex work (such as the Swedish model, criminalisation, decriminalisation etc) and the impact those system can have on homeless services, and importantly how and what homeless services can do to support people experiencing homelessness who may be engaging in sex work.

**Spotlight on Housing First 2.0 - A Renewed Beginning in Finland (Canal Café, Level 5, Croke Park)**

Finland has long been famed for its approach to mainstreaming Housing First in reducing homelessness. With goals of ending homelessness in Finland in 6 years Finland has a strong commitment to reform Housing First to strengthen it's efficacy in meeting the needs of people experiencing homelessness. Since 2019 a Change Lab methodology has been used to review the initial delivery of Housing First, which has led to Housing First 2.0. If Housing First 1.0 was launched by four wise men in Finland, then Housing First 2.0 has been produced by 30 wise women and men. This session will provide an overview of what Housing First 2.0 actually means for our collective mission on ending homelessness.

**In Conversation with Outreach Workers (Canal Café, Level 5, Croke Park)**

Outreach street work is a crucial part of supporting people experiencing homelessness as it allows for access to a large spectrum of places where people find refuge, and it can lead social workers to meeting people on their territory. Outreach workers find themselves at the middle ground between the most marginalised and often underserved individuals in homelessness and the services who could come to their support for accessing housing. It is a privileged position that makes it possible to create relationships of trust and a position which comes with great responsibility.

This one-hour session will be a conversation on what is the value of outreach work within the homelessness sector and with two outreach workers that will share their different perspectives and tools of conducting outreach.

In the context of the European Platform on Combating Homelessness launched in 2021, the topic of free movement and its connection to homelessness has been often discussed. We aim to contribute to this conversation by presenting the factors that push EU citizens to destitution and homelessness and identifying solutions for a better inclusion and access to rights, with a focus on accommodation. The presentations will include good practices implemented at local level, giving participants the opportunity to find out more about initiatives that aim to lift mobile EU citizens from homelessness. This workshop is dedicated to service providers who work with mobile EU citizens as well as cities' representatives where numerous EU citizens live in homelessness.

### **Simulation: Child & Youth Homelessness (All Start Suit 681 & 682, Level 6, Croke Park)**

What is it like to experience life on the street? How does it feel to navigate the child justice systems? What could we learn from these systems if we experienced them?

This experiential learning session will put every participant 'in the shoes' of a young person engaging with our systems that aim to address the needs of children and youth. Many of these youth have experienced high levels of trauma, violence, instability, and loss. Using integrative teaching and simulations developed in collaboration with young people with lived experience, we will explore what it is like to be a young person moving through various services and systems, including education, foster care, juvenile justice, homelessness, and more.

Participants will get a short orientation and then spend the bulk of the simulation in their player role as children involved in systems attempting to navigate supports. It will be followed by a robust reflection session as a group and individually with a focus on practical policy solutions to help reform our systems through the experiences of the most vulnerable young people.
