MEASURING HOMELESSNESS IN EUROPE - THE "EUROPEAN HOMELESSNESS COUNTS" PROJECT

ROOM: ROA

Homelessness is a persistent and complex social problem across Europe, necessitating robust, comparable data to inform policy responses and interventions. The "European Homelessness Count" project seeks to address this challenge by developing a more uniform methodology for homelessness counts that is applicable at the city level. In 2024, 15 cities were on board to elaborate and pilot a common methodology to capture ETHOS Light 1-3 and further groups in Europe, which was then scaled up to 35 cities in 2025. The workshop will serve as a forum to discuss the results and the lessons from the two year project. *This session is by invitation only.*

HOMELESSNESS AND THE CLIMATE CRISIS

ROOM: ORCHIDEA A

Last year saw the climate crisis in Europe intensify, as climate-driven heatwaves caused an estimated 16,500 additional deaths across European cities. Severe weather response strategies are becoming increasingly integral to homelessness provision in Europe with people sleeping rough particularly vulnerable to extreme weather events, heat and cold caused by the climate emergency. Climate change is also driving global displacement of people, contributing to growing migrant homelessness in Europe. More than 45 million people globally were displaced by extreme weather events such as flooding, droughts, storms and wildfires in 2024.

Join Depaul International as we explore the intersections of climate change and homelessness. We'll share findings from our new report, *The Case for Action on Global Homelessness*, examining how recognising homelessness as a frontline climate resilience issue has the potential to be transformative. Our workshop will draw on climate response and climate-resilient solutions to homelessness from Europe and around the world, and encourage practitioners to share learning and practices so we can improve our preparedness and solutions for people at-risk.

The open session will begin with a brief introduction to the working group and the intentions behind the magazine, followed by a few examples of different ways to pay tribute. Participants will then be invited to create their own tributes in whatever form feels right to them. They are free to decide whether they would like their contribution to be considered for publication in the magazine or kept private.

EARLY PREVENTIONS AGAINST ENERGY DEBT AND DISCONNECTIONS

Energy debt and disconnections can be a cause of homelessness and cause barriers for households to re-enter the housing market. While many countries offer support for energy bills and partial protection from disconnection, many households still suffer from disconnections and accessing support. In this session, three experts will share best practices on how energy companies can cooperate with social service providers to spot the early warning signs and resolve energy debt.

SOLACE CEE is an initiative fuelled by the urgent healthcare and housing needs of chronically homeless individuals with complex challenges and high-intensity service requirements. Themes such as mental health and substance-use support in Central and Southeast Europe will be discussed. This session discusses the 14th Comparative Study on Homelessness in Europe by the European Observatory on Homelessness, focusing on homelessness among non-EU migrants, including asylum seekers, refugees, people with international protection, and irregular migrants. The research examines how different EU Member States respond to non-EU migrant homelessness, highlighting system strengths, limitations, and the unique challenges faced by this population across Europe.

SUPPORT ON THE MOVE

Stowarzyszenie Pomocy i Interwencji Społecznej

We invite you to a study visit at the Mobile Support Point (MPP) - a service that combines mobility, specialist assistance and a harm reduction approach. MPP operates directly in the places where people experiencing homelessness stay, including those who do not use stationary services. It is one of the few spaces in Warsaw where support is also available to individuals under the influence of alcohol or substances, offered in an atmosphere of acceptance, safety and non-judgment. During the visit, participants will learn how the MPP operates, its philosophy based on accessibility and harm reduction, and the range of support provided: social counselling, crisis intervention, basic psychological assistance and help in planning further steps. We will also discuss the flexibility of the MPP, its ability to operate in different locations, and its crucial role for people who remain “outside the system,” for whom low-threshold support is often the only real form of contact with help.

FROM THE STREET TO THE SYSTEM: STREET WORKING IN WARSAW

Stowarzyszenie Pomocy i Interwencji Społecznej

Join us for an on-the-ground study visit exploring how street work is carried out in Warsaw. Guided by experienced streetworkers, participants will walk (and use public transport) along a specially designed route that showcases the unique characteristics of Warsaw’s outreach work. You will see a broad spectrum of interventions: from direct street-based support, through cooperation with public transport services and large shopping malls, and concluding with a visit and a moment of rest at the Municipal Sobering-Up Centre. During the walk, we will present several practical solutions developed by our organisation, including the ICE (“In Case of Emergency”) declaration used to support safe and informed interventions. Together, we will also engage in a conversation on best practices, with a particular focus on multisector cooperation and the partnerships that make effective street work possible in a large, dynamic city.

ETEZJA - A HOME WHERE CHANGE BEGINS

We invite you to a study visit at the “Etezza” Home, dedicated to pregnant women as well as mothers and fathers with children who have found themselves in a difficult or threatening life situation. It is a space that combines safety, specialist support, and an atmosphere of everyday care. A place where, day by day, the process of rebuilding a sense of agency, stability, and relationships takes place. During the visit, participants will learn about the home’s operating principles, its goals, and its philosophy of work. They will also discover how support is provided to both parents and children - from psychological and legal assistance to social and educational support – and gain insight into the cooperation model with various institutions. In addition, we will present our housing program, which enables families to gradually transition from emergency accommodation to independent living.

What are the principles of a partnership between the local government (building owners) and NGOs to achieve the social goal of adapting a vacant space into apartments and a social enterprise café for people experiencing homelessness. How can renovations include volunteers in construction work, use donations from construction companies as part of their corporate social responsibility and renovate a large building while preserving its historic elements and traces of history. All these questions and more can be answered by visiting the project led by Habitat for Humanity Poland.

The Warsaw House Foundation is an LGBTQ+-specific organisation supporting young people (18–29) experiencing homelessness through housing, psychosocial support, and community-building, including both Polish youth and LGBTQ+ migrants and refugees. The site visit will include a tour of our office and housing space, rooms used for therapy and group work, as well as a space planned for renovation to expand future housing capacity. Participants will learn about our housing-first, trauma-informed approach and see how community spaces are used for peer-led and youth-informed initiatives, including the Trans Lounge – a regular group space for trans and non-binary youth focused on support, connection, and well-being.

HARMONISING HOMELESSNESS DATA COLLECTION IN THE EUROPEAN UNION

ROOM: STARZYŃSKIEGO

In the Lisbon Declaration (2021), EU Member States committed themselves “to work towards the ending of homelessness by 2030.” Achieving this ambition requires reliable and comparable data on both the scale and the profiles of people experiencing homelessness (PEH) across the European Union. Without harmonised data, the EU cannot effectively monitor progress, assess policy effectiveness, or support mutual learning between Member States.

Harmonising homelessness data, however, is methodologically and institutionally complex. As demonstrated by European Homelessness Counts, these challenges are particularly pronounced in the field of homelessness due to variations in definitions, service provision systems, administrative data infrastructures, and the lived situations of people experiencing homelessness across Member States.

CITIES AT THE FOREFRONT OF HOUSING FIRST – IMPLEMENTING A HOUSING FIRST APPROACH TO ADDRESS HOMELESSNESS

ROOM: MIKOŁAJSKIEJ

Cities are often at the forefront when it comes to implementing and scaling up Housing First. This workshop will explore what is needed for a successful city-wide approach to Housing First.

Cities from different European countries (Finland, The Netherlands, France, Poland, Czechia, Ireland) will share insights on their successes and challenges, on accessing housing and how to build long-term relationships with key actors.

Following a panel discussion, where speakers will present insights on scaling up Housing First on a city level participants will engage in group discussions facilitated by the speakers, allowing for deeper exchanges on best practices, common barriers, and practical solutions.

DEINSTITUTIONALISATION AND THE HOMELESS SECTOR

ROOM: RATUSZOWA

This session will discuss the deinstitutionalisation model in Poland and Spain. In Poland, an EU-funded project is currently developing a deinstitutionalisation (DI) model, and the workshop will present its preliminary results, including a service framework structured around three areas: homelessness prevention, transition from institutional shelter-based services to housing-led solutions, and outreach services. In Spain, the closing of a shelter led HOGAR SÍ and Provivienda, in coordination with the Madrid City Council, to kick start an innovative project, Rights to Housing. With a transition to a model of community and personalised care, the project aimed to design and implement a model to transform the homeless care system. The session will provide an opportunity to reflect on shared challenges and lessons learned across both national contexts.

PRISON RELEASE AND HOMELESSNESS: THE POLISH EXPERIENCE ROOM: MIKOŁAJSKIEJ

PREVENTING EVICTIONS: LEGAL REFORM AND INTEGRATED PREVENTION IN EUROPE

ROOM: KISIELEWSKIEGO

Eviction prevention is an essential strategy for tackling homelessness. This session explores legal, policy and practice-based approaches to preventing evictions in Europe, with a focus on Ireland and Austria.

Threshold (Ireland) will present its work combining free, independent advice and support for people experiencing housing difficulties with advocacy for stronger tenant protections and fairer rental laws. The presentation will reflect on how frontline service delivery informs policy reform efforts.

The Austrian Ministry for Social Affairs will present the Wohnschirm programme, a nationwide eviction prevention scheme combining social work counselling with financial support to address rent arrears or support relocation. Implemented through NGOs and publicly funded, Wohnschirm demonstrates how early intervention can prevent homelessness at scale.
