CONCLUSIONS

YOUNG WOMEN AT RISK OF BEING TREATED AS DEFECTIVE

CRISIS CENTRES

NOT SOCIALIZED TO BE INDEPENDENT AND RESPONSIBLE - THE SOCIO-INSTITUTIONAL SYSTEM IS TO BLAME (SYSTEM TALK)

SINGLE MOTHERS' HOMES

IMMORAL AND PROMISCUOUS, IN NEED OF MORAL CORRECTION – AN INDIVIDUAL IS TO BLAME (SIN TALK)

CRISIS CENTRES

INFORMAL PRACTICES OF SELECTING WOMEN
WITH MORE RESOURCES

EXPECTING EFFECTIVE SELF-SUFFICIENCY
(REVOLVING DOOR)

SINGLE MOTHERS' HOMES

MORALLY JUDGING , VICTIM-BLAMING

NOT EMPOWERING, REPRESSING AGENCY

HIGHER STANDARD, SUPPORT AND CARE

- MOTHERS' HOMES WILL GET MORE FINANCING BUT ARE OUTSIDE OF STATE CONTROL
- ACKNOWLEDGING HOMELESSNESS AS ONE OF PRIORITY PROBLEMS
- FINDING LONG-TERM HOUSING SOLUTIONS FOR WOMEN
